Addressing about Fisheries and Ocean Resources

We have so far failed to tap the vast potential of the ocean resources surrounding us. I am determined to change this situation and develop the fisheries industry and to bring it to a level of the industry in Japan and Thailand. While I was Minister of Fisheries, I established an Ocean University as a first step towards this goal.

The coastal guard, which was initiated by me, will be strengthened further in order to protect our ocean resources. I will take action to utilize these resources to the maximum enhancing the employment opportunities and increasing the national production.

My priority will be relies the potential of the deep seas around Sri Lanka which possess large quantities of fish. To do so 50 trawlers will be deployed to engage in Deep -Sea Fishing.

I will also arrange to provide 500 multi-day boats at concessionary prices to the costal Fishermen in Sri Lanka, within a period of 3 years.

I will develop 100 fisheries harbors, anchorages, boat yards, and fishery crafts centers along the coastal line.

A fuel subsidy will also be given to Fishermen with effect from January 2006.

I will provide the required incentives to the private sector to make available fisheries crafts with new technology and to provide fishing gear to Fishermen. Action will also be taken to develop fresh water fishing in new rehabilitated thanks, reservoirs and ponds.

I will provide land, capital, knowledge, and technology to set up 150 brackish and fresh water prawn farms in 10 zones.

Factories for fish processing and canning will be set up in the North, East, and South in close proximity to fishery harbours and anchorages.

I will popularize the breeding of ornamental fish. The government will intervene in securing new technology, information, and incentives to our small and medium scale ornamental fish breeders to penetrate into the international markets.

I will take measures to prohibit poaching by foreign fishermen in our territorial waters.

I will also take measures to curb the use of destructive fishing methods.

I will also take arrangements to replace nets and other fishing gear at subsidize rates if these are lost or destroyed through natural disasters. Lost fisheries crafts, nets, fishing gear and fishery houses will be replaced within a period of 3 months.



Message from The Hon. Minister



Minister of Fisheries & Aquatic Resource Development – Minister Hon. Dr. Rajitha Senarathna

Hon. Dr. Rajitha Senarathna, He take his great pleasure in issuing a message and addressing that on the Occasion of launching a much needed website for the CFC of Ministry of Fisheries and Aquatic Resources Development.

It should be noted that the turnover of CFC was Rs. 68 Million in May 2010 at the time I took over the Ministry. The total sale by the corporation was Rs. 185 Million per month at that time. However, over the last six (6) months for sale of Fish has been tremendously increased with the quality by 100% ensuring 370 MT per month. And the value of it is Rs. 137 Million which is also a 100% increase. The CFC has been able to reduce the losses, which they have been sustaining over the period of gradually and now is in the process of making profits at least the breakeven.

The CFC had been selling around 7 Mt a day then, However the CFC is now able to sell around 15 - 20 Mt a day at present. The Fish Industry mafia, which is operating at present in the high Sea. The Ministry is in process to controlling same and also irradiates the mafia.

The number of CFC outlets has been increased from 48 to 84 and planning to establish 250 stalls all over the Island at the end of 2011. In the meantime, Fish is supplied to 152 Sathosa sales Outlets and Economic Centers all Over the Sri Lanka. It has been the idea that the CFC to operate at profits at the same time to supply Fish at 50% reduce price to consumers in near future. The Frozen Packet Fish production for August 2010 achieved 46.68% Mt with liaises to lack Sathosa Outlets and it is 47.13 Mt per year in 2009 without the Lak Sathosa liaise . The Frozen packed Fish production indicates clear achievement recording 62.5Mt.

In March 2011, Fish Prices in general have been reduced by 8% to 22% during the period, after I took over the Office and hoping to create a situation.



Plans are been carried out to purchase 90 Fish Boats for CFC in order to increase the Fish harvest in CFC, which leads to provide protein sufficient Fish at low price, Increase the Fish Consumption, decrease the price of Fish via market competition under CFC's intervention.

By establishing mini CFC sales Outlets at Co-op Cities, Sathosa Outlets all over the Island, Rural Consumers are able to buy good quality Fish at lower prices as well as Urban Consumers. Van Sales which have been arranged also helping to shape the same aspect.

The revenue of every CFC Outlet are been increased from 2.5 - 4. Million at present. The Fisheries Industry is stepping to a new era. And in the future CFC Outlets are design to provide Marine water Fish as well as Fresh water Fish.

My aim is to increase the Local Fish production of 339,730 Mt, which was at 2009, up to 400,000 Mt at the end of 2011, and increase the production at Eastern Coast up to 43%, Deep Sea and Offshore Production up to 194%, and Fresh water aquaculture up to 100% and win the international waters.


A mega projects are designed to achieve the Inland Fisheries and aquaculture production up to 98,000 Mt at 2013 which is now at 45,560 Mt and increase the total production up to 686,000 Mt per year.

Presently we are planning to make the Mahinda Chinthana Future Vision a reality by enhancing Ocean recourse when H. E. the President make country become the Wonder of Asia, Fisheries Industry be the Wonder of Sri Lanka.





Due to this, the Country is struggling to provide a better life style for the Fisheries Sector, and gradual increase in the poverty level of the

country, and the Country could not earn any additional income, which is a burden to the country. The main core reason is that the Democratic Socialist Republic of Sri Citizens Lanka or the

belonging to the Island have not yet experience the commercial or Industrial Fishing Vessel Operations. Even the Domestic Financial Institutions have no idea about the extreme level of Fishing and are not capable to help (provide with required fund) nor motivate this sector. 



HISTORY AND NATURE OF THE COMPANY CEYLON FISHING INDUSTRIES LIMITED

CFI - HISTORY 1ST STARTED AS OSAKI IN 1998

Sheikh Riyal Bin Ismail founded M/S. Osaki Fishing Industries Lanka Private Limited and that Has Been Established on 1998. The Company was approved by the **BOI** (Board of Investment of Sri Lanka) and also the **Ministry of Fisheries and Aquatic Resources**, for the purpose of building the Nation and Making a new lifestyle for Fishermen and for the Community. Many Incentives was **granted** for Immediate Implementation.

This company Main objective was to contact Offshore & Deep Sea Fishing, thereby to Set-up a Fish Processing, Canning, and Fish Meal Plant together with Industrial Fishing vessel Operations and provide Logistics Supplies. That In order to revolutionize the lifestyle of Sri Lankan Fishermen and the Entire Communities.

This project was Politically Motivated by our **President H. E. Mahinda Rajapaksa**. Who also approved this project when He was the Minister of Fisheries and Aquatic resources of Sri Lanka in 1998. In addition, this project was encouraged by the Minister of Ports, Shipping, Rehabilitation and Reconstruction the **Late Hon. Minister M. H. M. Ashraff.** Moreover, this Project is now Politically, Strongly again motivated by the **Hon. Minister of Fisheries & Aquatic Resources, Dr. Rajitha Seneratne**.

The project was delayed due to the 30 years of Civil war and non-existence of **Oluvil Port** during the period of 1998, and was postponed due to the Tsunami of 2004, which had greatly affected the launching of the project for its early implementation.

While thanking the Sri Lankan Government for the Construction of the new Commercial and Industrial Fisheries harbor in **Oluvil Port** with Fish processing plant that has been funded by **Nordea Bank, in Euro 46.3 Million.**



CFI-HISTORY BORN AGAIN ON 25 JULY 2011

This Company is now Re-Established and Re-Incorporated under the Company Act No. 7 of 2007 as Limited Liability Company under the Name of "Ceylon Fishing Industries Limited" and issued a Certificate of Incorporation by the Registrar General of Companies of Sri Lankan Government on 25 July 2011 in Colombo.

The Company was comprised of Five Directors; subsequently the Company was able to increase its Directors to 15. In addition, intends to increase its shareholders by a public issue of shares, when the Company needs to increase the Source of Investment for the regular expansion of the Company. This Company was formed to focus **Research & Development** on the Entire **Marine Activities of Offshore and Deep Sea Fishing.** Thereby set-up Fish Processing, Canning and Fish Meal Plant that to be one of the Industry of Sri Lanka, thereby to Create and Expand the rapid Exports of Fresh, Frozen, Canned, Dry Fish and Fishmeal Products, to provide and satisfy the requirements of the Domestic Market, In addition to this strongly provide supports to Secure the Food Security of the Nation, as well as to Feed the Regional & International Markets; Especially USA, UK and Rest of the EU Countries, As well as Middle East, African Regions & Continents.










